In Schedule 2, Part 1 – Administrative Condition

- 2. In Condition 1.1:
 - (a) delete the 'and' in clause (h);
 - (b) delete the period at the end of clause (i) and replace with '; and', and
 - (c) insert new clause (j) as follows:
 - (j) Modification 5.
- 3. Insert new Condition 1.5A, after Condition 1.5 as follows:
 - 1.5A Prior to the occupation of the storage shed approved under MP06_0159-Mod-2 and retrospectively amended under MP06_0159-Mod-5, the Applicant is to obtain an Occupation Certificate from the Certifying Authority and provide a copy to the Planning Secretary.

In Schedule 2, Part 2 – Specific Environmental Conditions

- 4. Insert new Condition 2.18A, after Condition 2.18 as follows:
 - 2.18A All rainwater from the structures approved under MP06_0159-Mod-5 is to be collected and integrated into the existing stormwater management system within the site.

In Schedule 2, Part 5 – Specific Environmental Conditions

- 5. Immediately after Condition 5.4, add new heading titled "Revision of Strategies, Plans and Programs", and add new Conditions 5.5 and 5.6 as follows:
 - 5.5 Within three months of:
 - a) the submission of an incident report under condition 6.9;
 - b) the approval of any modification of the conditions of this consent; or
 - c) issue of a direction of the Planning Secretary under Condition 1.2A,

the strategies, plans and programs required under this consent must be reviewed, and the Planning Secretary must be notified in writing of the outcomes of any review.

5.6 If necessary to either improve the environmental performance of the development, cater for a modification or comply with a direction, the strategies, plans and programs required under this consent must be revised, to the satisfaction of the Planning Secretary. Where revisions are required, the revised document must be submitted to the Planning Secretary for approval within six weeks of the review required under condition 5.5, or such other timing as agreed by the Planning Secretary.

Note: This is to ensure strategies, plans and programs are updated on a regular basis and to incorporate any recommended measures to improve the environmental performance of the development.
